Weinman, the duly appointed Chapter 7 trustee of the Estate of Matt Garton & Associates, LLC, respectfully requests entry of the Corrected Order submitted herewith, granting the his Motion and authorizing the Trustee to sell the Personal Property, as defined therein, to Matt Garton pursuant to 11 U.S.C. § 363(b) as set forth herein.
