**NOTICE OF RATE CHANGE**

COMES NOW Allen Vellone Wolf Helfrich & Factor, P.C. (“Allen Vellone” as counsel for Jeffrey A. Weinman (the “Trustee”), the Chapter 7 Trustee of the Estate of Matt Garton & Associates, LLC, hereby submits this Notice of Rate Change for Rachel A. Sternlieb.

1. On October 16, 2019 (the “Petition date”), Matt Garton & Associates, LLC (“Debtor”) filed a voluntary petition under Chapter 7 of the United States Bankruptcy Code. (the “Bankruptcy Code”) in this Court commencing this bankruptcy case.

2. Jeffrey Weinman (the “Trustee”) was appointed as the Chapter 7 Trustee of the bankruptcy estate of the Debtor (the “Estate”). Dkt. No. 6.

3. On October 24, 2019, Trustee filed an Application to Employ Allen Vellone as counsel to assist him in administering the bankruptcy estate of the Debtor and to represent the Trustee in connection with litigation matters arising in this case, including but not limited to any matters arising under §§ 544, 547, 548 and/or 549 of

the Bankruptcy Code. Dkt. No. 8.

4. The Court authorized the Trustee's employment of Allen Vellone by Order entered on October 28, 2019. Dkt. No. 9.

5. The Application to Employ Allen Vellone lists the professionals' hourly rates for services as of the date of the application. Dkt. No. 8.

6. As contemplated in Allen Vellone's engagement agreement, Ms. Sternlieb's rates were increased in 2020 and a Notice of Rate Change was filed on October 28, 2020, reflecting same. Dkt. No. 60.

7. In 2021, Ms. Sternlieb's hourly rate increased from \$285.00 to \$295.00 per hour consistent with her years of experience and practice areas of concentration.

8. As contemplated in Allen Vellone's engagement agreement with the Trustee the undersigned hereby notifies the court of this rate change that took effect January 1, 2021.
